Larisa Gorbacheva submitted the following written comments this agenda to item: "NSD needs to address the issue of having in place various methods to settle losses resulting from the application of Article 8.5 of Federal Law No. 39-FZ dated 22 April 1996 "On the Securities Market" (including a special guarantee fund, liability insurance, and increase of the CSD's capitalization); simulate scenarios of application of Article 8.5 of the said law and consequences of its application; establish a working group, prepare proposals to make amendments to Article 8.5, and submit those amendments to the Customer Committee for discussion."

- 2. Recommend that NSD's Supervisory Board approve the Amended and Restated Terms and Conditions of Depository Operations of National Settlement Depository.
