

#### **REGULATORY BASIS**


- Article 5 (parts 15, 16), Law 452-FZ of 04 August 2023;
- 2. The Decision of the Board of Directors of the Bank of Russia "On Establishing the Procedure and Terms for Automatic Conversion of Securities of Foreign Issuers Certifying Ownership of Shares of Joint-Stock Companies with the Status of an International Company into Shares of Such Joint-Stock Companies" dated 15 September 2023 (the "CBR Decision").



#### **PARTICIPANTS**

- 1. An international company registered in the Unified State Register of Legal Entities due to a change of personal law by the international legal entity by way of redomiciliation (the "international company", "IC");
- 2. The registrar for shares of the international company (the "registrar"), keeping the client account of depositary programmes;
- Central Securities Depository;
- 4. CSD's clients
- Russian depositories keeping records of international securities (DRs) and having accounts of persons acting on behalf of other persons opened in international organisations to provide such record-keeping (the "Level 1 Depository").


